

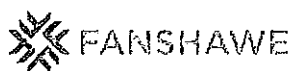

David

I would like to propose a late degree audit change for the Information Security Management Program. Specifically, I would like to change the name of INFO-6012 from *Hacking and Exploits* to *Ethical Hacking and Exploit Detection*. This change is proposed as a means of risk management for the College and the School of IT.

The Hacking and Exploits course here at the School of IT teaches students how to recognize information security concerns by demonstrating the actual exploits in a forensic manner. This experiential approach teaches the students what to look for and how to resolve such exposures. By way of example, curriculum was updated to include the Heartbleed vulnerability that was disclosed in April 2014. This bug gave hackers the ability to obtain passwords and logins from unpatched websites. The Canadian Revenue Agency is just one of many organizations that were attacked.

As we educate our students how to protect Information Systems from these vulnerabilities, it is important as a college that we manage the risk of students using their Hacking skills in an unwanted way. I would suggest that we rename the course from *Hacking and Exploits* to *Ethical Hacking and Exploit Detection*. This new course name would serve the college better, should we ever need to explain to a media source that we taught Ethical Hacking as opposed to simply Hacking.

No other attributes of the course (name, number nor content) are subject to this change request, simply the course title.
