


In F18 the curriculum of the IDP3 program was changed to align with the new VIS1 program to have a common first year. At the same time some of the second year courses were renamed to be consistent between the programs. One of the courses MMED-3037-3D Authoring was changed to MMED-1058 – Motion Design 2, but the original course was not removed from the Degree Audit by mistake. As these courses are the same content, just a different name, MMED-3037 will need to be removed. This change will also result in a decrease in 45 hours over the program.
