Your proposal dated March 29, 1985 to extend the duration of the Child Care Worker program has been assessed by the College Affairs Branch.

Please accept this as your approval to increase the duration of your Child Care Worker program from two years, four semesters to three years, six semesters, including appropriate field placements. The enrolment quota remains at a first year intake of 53, including the first year of both two and three year programs.

The effective date of approval of the three year program is September, 1985. However, since some students already may have been enrolled in the two year program (MCU Code 50701, APS number 01013) for the September 1985 intake, the two year program will continue to be shown as "active" on the Approved Programs List.

It is expected that by September 1987, no students will be enrolled in either level of the two year program and that the program will be cancelled. You are requested, therefore, to submit a Notice of Program Suspension or Cancellation (Reference Memorandum 83-F-1) at the appropriate time to inform the College Affairs Branch of the cancellation of the two year program.

I understand that in consequence of the action taken
by the Council of Regents, colleges are to modify
the format of the Child Care Worker program in order
to provide a minimum of 1200 hours of practicum.

I attach a proposal with respect to this program
which describes the manner in which we intend to
offer it and I should appreciate your arranging for
this proposal to receive early consideration.

You will note that it is our intention to modify the
program effective September 1985 and we shall, there-
fore, have to inform the new entrants of our plans in
